

### Laura Atria-Newitt

Laura Atria-Newitt is a seasoned public art professional, currently serving as the Public Art and Artist in Residence Program Manager for the City of Pompano Beach and as the President of the Florida Association of Public Art Professionals. With over thirteen years in public art administration, she has a successful track record in developing and implementing art programs and serving on various boards and panels, including the Broward Cultural Council. She holds dual degrees in Studio Art and Art History from FAU. Her expertise has been key in creating Public Art Master Plans, securing grants, and earning accolades, including a one million-dollar Bloomberg Philanthropies Grant.

In addition to her public art advocacy, Atria-Newitt is a professional artist whose work often focuses on voyeurism, the female, self-healing, and self-definition. She often creates personified characters in her paintings as a way to document her desire to process past traumas and better understand the world. She received the Broward Cultural Division Artists Support Grant in 2023, 2022, and 2021 and was commissioned by President Joe Biden in 2020 to create banner murals for his South Florida Presidential Campaign. As a professional visual artist and Public Arts Program Manager, Atria-Newitt brings academic and hands-on knowledge in addition to familiarity of artistic theory, principles, and materials to the projects she encounters.



# Elayna Toby Singer

As a leader in the national public art ecosystem for over 20 years, Elayna Toby Singer directs Palm Beach County's Art in Public Places Program. In collaboration with artists, design professionals and community stakeholders, Elayna guides transformation of plazas, buildings, streetscapes and gardens into "Art Places" that amplify client missions, enhance community pride, and improve quality of life. She curates and manages the permanent art collection and changing exhibitions at Palm Beach International Airport, supporting thousands of local artists, while advancing tourist development and the Creative Economy. Elayna conceived and led ARTist

in the Garden master planning to strategically integrate art into the County's botanical garden. She received Art Synergy's "Visionary Award" for her leadership and contributions to the arts in Palm Beach County.

Elayna currently serves on the Board of Florida Association of Public Art Professionals and Chairs the Design & Planning Community for the American Public Gardens Association. She previously served on Americans for the Arts Public Art Advisory Council, Urban Land Institute Creative Placemaking national advisory group, and was a panelist for the National Endowment for the Arts Our Town Grant.

Her career in creative placemaking began in botanical gardens and arboreta where she created landscapes, exhibitions and experiences to engage communities in the artistry, conservation and multicultural uses of plants. Elayna received a BA in Cultural Anthropology and as a Longwood Gardens Fellow earned a MS in Public Horticulture Administration and a certificate in Nonprofit Museum Management.

As a social practice artist, Elayna Toby partners with public and private organizations, offering participatory communiTree kinetic public art interventions, and nature arts programs, to promote healthier people and places.
